

# Aamal Company (AHCS)

- > Net profit increased by 8.3% YoY (-21.8% QoQ) to QR102mn in 1Q2025 due to higher revenue.
- > Revenue came higher by 6.8% YoY (+15.5% QoQ) to QR 580mn in 1Q2025.
- > Gross profit decreased by 1.3% YoY to QR129mn (+4.6% QoQ) while the corresponding margin came to 22.2% in 1Q2025 (vs. 24.0% in 1Q2024).
- > Operating profit of QR88mn was up by 3.4% YoY (-27.4% QoQ) and margin came to 15.1% in 1Q2025 (vs. 15.6% in 1Q2024).


- > For 1Q2025, EPS came to QR0.016 vs. QR0.015 in 1Q2024.
- > As of 28th April 2025, the stock decreased by 1.4% YTD, Outperforming the QSE Index, which was down by 2.5% YTD.
- > The stock is currently trading at a TTM P/E multiple of 12.1x.




### Quarterly Sales Trend (QRmn)
