

Al Khaleej Takaful Insurance Co. (AKHI)


- > Net profit decreased 17.1% YoY to QR18mn in 1Q2025 primarily due to higher expenses and lower total income.
- > Takaful revenue rose by 29.1% YoY to QR125mn in 1Q2025.
- > For 1Q2025 takaful services result increased by 68.6% YoY TO QR3mn in 1Q2025.
- > For 1Q2025, EPS came to QR0.07 vs. QR0.084 in 1Q2024.
- > As of 30th April 2025, the stock has decreased 3.3% YTD, Underperforming the QSE Index, which was down by 1,1% YTD.




Quarterly Takaful Revenues Trend (QRmn)




Quarterly Earnings Trend (QRmn)
