

Gulf International Services (GISS)

- > Net profit for the period reached QR222mn, compared to a profit of QR161mn in 1Q2024 representing an increase of 37.7% YoY (+60.4% QoQ), primarily due to higher revenue and gross profit in 1Q2025.
- > Total revenue increased by 21.3% YoY (+3.8% QoQ) to QR1,140mn in 1Q2025.
- > Gross profit grew 50.1% YoY to QR297mn (+31.3% QoQ) while the corresponding margin increased by 5ppts YoY (+5.5 ppts QoQ) to 26.1% in 1Q2025.
- > For 1Q2025, EPS came at QR0.119 vs. QR0.087 in 1Q2024.


- > **As of 30**th **April 2025, the stock decreased 7.4% YTD,** Underperforming the QSE Index, which was down by 1.1% YTD.
- > The stock is currently trading at a TTM P/E multiple of 7.4x. For now, we maintain our PT of QR 3.90/share and Outperform rating.



Quarterly Sales Trend (QRmn)




Quarterly Margin Trend
