

Earnings Flash Note Mesaieed Petrochemical Holding Company 3Q 2024/9M 2024



Mesaieed Petrochemical Holding Company (MPHC)

- > Net profit decreased by 36.2% YoY to QR168mn (-17.6% QoQ) in 3Q2024 owing to a lower share of results from joint ventures. For 9M2024, net profit fell 33.2% to QR567mn.
- > The share of results from joint ventures fell by 41.4% YoY to QR138mn (-18.0% QoQ) in 3Q2024. For 9M2024, the share of results from joint ventures was down 39.9% to QR462mn.
- > For 3Q2024, EPS came at QR0.013 vs. QR0.021 in 3Q2023. For 9M2024, EPS came at QR0.045 vs. QR0.068 in 9M2023.
- > As of 28th October 2024, the stock has decreased 10.5% YTD, Underperforming

the QSE Index, which was down by 3.0% YTD.


> The stock is currently trading at TTM P/E multiple of 25.3x, higher than its 1Y historical average of 21.2x.















Investment in Joint Ventures (QRbn)
