

Lesha Bank (QFBQ)

- > Net profit rose 40.6% YoY to QR40mn (+28.3% QoQ) in 1Q2025 driven by higher fee & other income.
- > Net income from financing assets decreased by 43.7% YoY (-23.3% QoQ) to QR10mn in 1Q2025.
- > Total income rose 17.0% YoY (+27.4% QoQ) to QR72mn in 1Q2025.
- > As of 1Q2025-end, the book value per share stood at QR1.19 vs. QR1.12 in 1Q2024 (4Q2024: QR1.20).


- > For 1Q2025, EPS came at QR0.036 vs. QR0.026 in 1Q2024. (4Q2024: QR0.028).
- > As of 16th April 2025, the stock decreased 5.8% YTD, Underperforming the QSE Index, which was down by 3.5% YTD.
- > The stock is currently trading at a TTM P/B multiple of 1.0x.


Quarterly Total Income Trend (QRmn)
