1. The commissions are charged for all clients unless otherwise agreed
2. issuing a certified check (Certifying checks for import purposes requires a commission of 5 per thousand according to the decision of the Central Bank of Syria)
3. Settlement transactions for regular / certified checks includes: stopping ,returning, rejecting a check/ amending check data / Checkbook destruction / settling a returned check / depositing a certified check into the account, the commission of which is collected from the beneficiary.  
When destroying / canceling / stopping more than one check at the same time, the commission will be collected once for all check
4. The commission is determined case by case, in addition to the commission of correspondent banks, SWIFT and postal banks, if any
